Candidate Eligibility Requirements <i>Requisitos de Elegibilidad del Candidato</i>	Deadline to File Candidate Application <i>Fecha Límite Para Presentar la Solicitud de Candidato</i>
An individual is eligible to be a candidate for, or elected or appointed to, a Texas school board if the individual: <ul style="list-style-type: none"> <li>• is a United States citizen;</li> <li>• is 18 years of age or older on the first day of the term to be filled at the election or on the date of appointment, as applicable;</li> <li>• has not been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated or partially mentally incapacitated without the right to vote;</li> <li>• has not been finally convicted of a felony;</li> <li>• has resided continuously in the state for 12 months and in the territory from which the office is elected for six months immediately preceding the following date:                         <ul style="list-style-type: none"> <li>○ for an independent candidate, the date of the regular filing deadline for a candidate's application for a place on the ballot;</li> <li>○ for a write-in candidate, the date of the election at which the candidate's name is written in; or</li> <li>○ for an appointee to an office, the date the appointment is made;</li> </ul> </li> </ul>	<p><b>Friday, February 14, 2025 at 5:00 p.m.</b></p> <p><b><u>Application Required:</u></b>  <a href="#">Application for Place on General Election Ballot Form</a> (no filing fees required)</p> <p><b><u>Additional links:</u></b>  <a href="#">Elections Division Website</a> and <a href="#">forms</a></p> <p><a href="#">Texas Election Code</a> sections 141.001 (eligibility requirements) and 141.0031 (application requirements)</p>
